Tournament: **Shiai Competition to start at 9 a.m.**, Kata not before 11 a.m.

Rules: Current (2019) IJF rules (modified double elimination). Competitors are required to bring their own white and blue belts. All E Level competitors must have at least a white gi and are encouraged to bring a blue gi as well. A match between two competitors with blue gis will not be permitted. No Shime Waza allowed under 13 and no Kansetsu Waza under 18 or for any Novice. Due to junior points being awarded, competitors may not fight a second division within their age group unless it is an open division. You may fight juniors & seniors or Juvenile A or B, and IJF. You also **MUST** fight in your own age division. Seniors, Veterans, Novice, and all other non-point-able competitors may fight in multiple divisions.
Director may adjust weight categories if necessary for safety.

Note: You must be a USA Judo member, and a US citizen, to be eligible for points.

Eligibility for all other divisions: Must be a current member of USA Judo, USJA, USJF, ATJA, AJJF, or their National Org.

MISC. INFORMATION: During weigh-ins, competitors will be permitted to test weigh on the official scale as often as they like. We promise to do everything possible to run this tournament as fair as humanly possible, with our main concern and attention being given to the competitors.

CATEGORIES: Each Category is based on the contestant's year of birth. All weights are in kilograms. For each division, the weight will be over the next lower weight and up to and including the weight listed.

BANTAM 2 (Born 2012): **Female AND Male:** 21, 25, 30, +30 kg

BANTAM 3 (Born 2011): **Female AND Male:** 23, 27, 31, 35, +35 kg

INTERMED 1 (Born 2009-2010): **Female AND Male:** 26, 30, 34, 38, 43, +43 kg

INTERMED 2 (Born 2007-08): **Female AND Male:** 28, 31, 34, 38, 42, 47, 52, +52 kg

JUVENILE A (Born 2005-2006): **Female AND Male:** 36, 40, 44, 48, 53, 58, 64, +64 kg

Cadet (Born 2002-2004): **Female:** 40, 44, 48, 52, 57, 63, 70, +70 kg

Male: 50, 55, 60, 66, 73, 81, 90, +90 kg

IJF JUNIOR (Born 1999-2004): **Female:** 44, 48, 52, 57, 63, 70, 78, +78 kg, Open

Male: 55, 60, 66, 73, 81, 90, 100, +100 kg, Open

Juvenile B are eligible to also enter IJF Junior.

Senior Women (All Ranks): -52, -57, -63, -70, -78, +78kg

NOVICE DIVISIONS: White & yellow belts ONLY Light, Medium, Heavy for each.

NOTE: Novice MAY fight Novice and in their age and weight category in the pointable divisions. A separate entry form and fee are required. The Junior Point divisions will be completed BEFORE the Novice divisions.

Match Duration: IJF & Cadet matches will be 4 minutes. All other divisions, will be 3 minutes.
